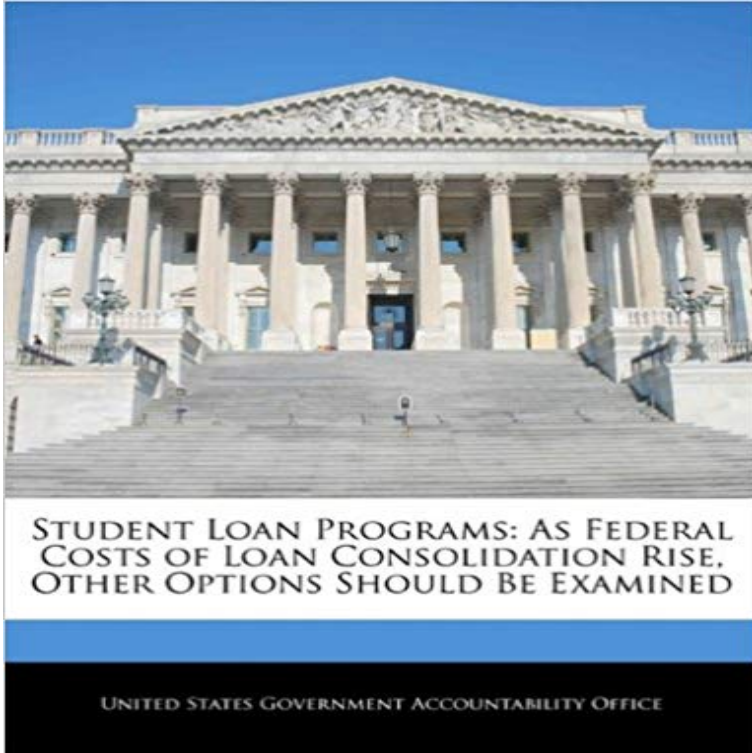


# Student Loan Programs: As Federal Costs of Loan Consolidation Rise, Other Options Should Be Examined
