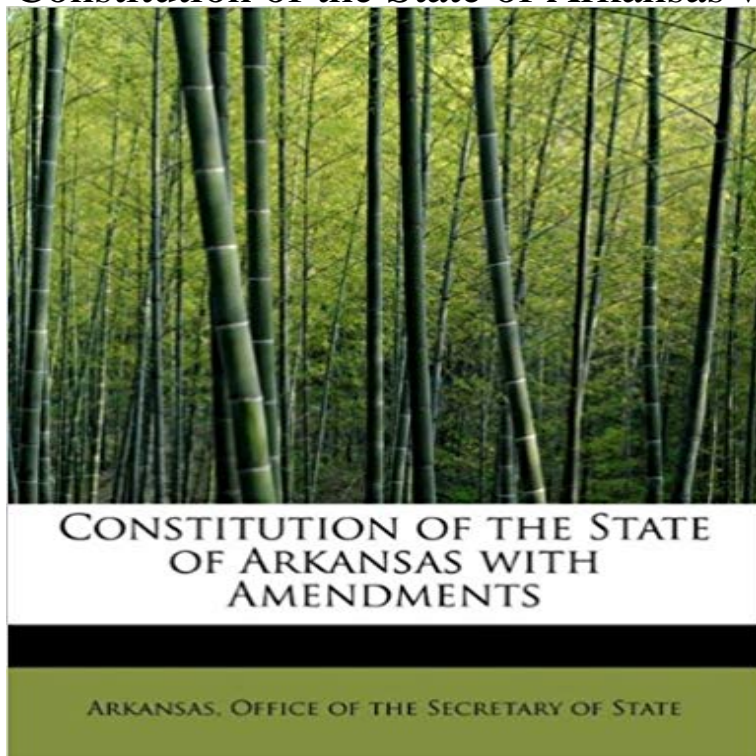


Constitution of the State of Arkansas with Amendments
