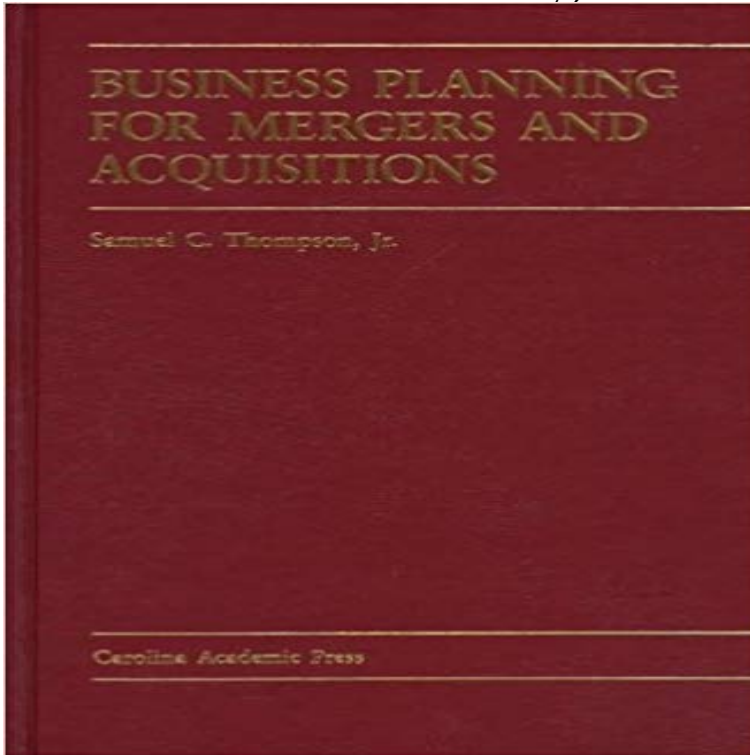


# Business Planning for Mergers and Acquisitions (Artech House Telecommunications Library)



The practice of mergers and acquisitions (M&A) is one of the most challenging areas of the law, and this book is designed to help the reader gain both a practical and theoretical understanding of many of the legal problems a business lawyer will likely encounter in practice when working on M&A deals. The book also focuses on modern valuation principles and on accounting considerations. Separate chapters address international M&A and M&A in the following industries: telcom; media and entertainment; banking and financial institutions; and public utilities. The book also addresses issues that can arise in structuring a joint venture or other strategic alliance, which may be used as an alternative to M&A.
