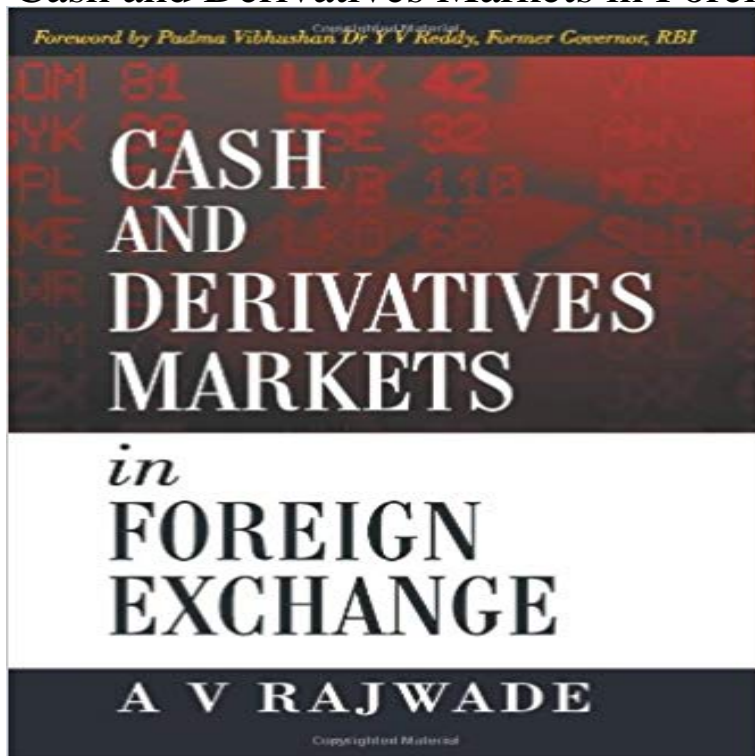


Cash and Derivatives Markets in Foreign Exchange
