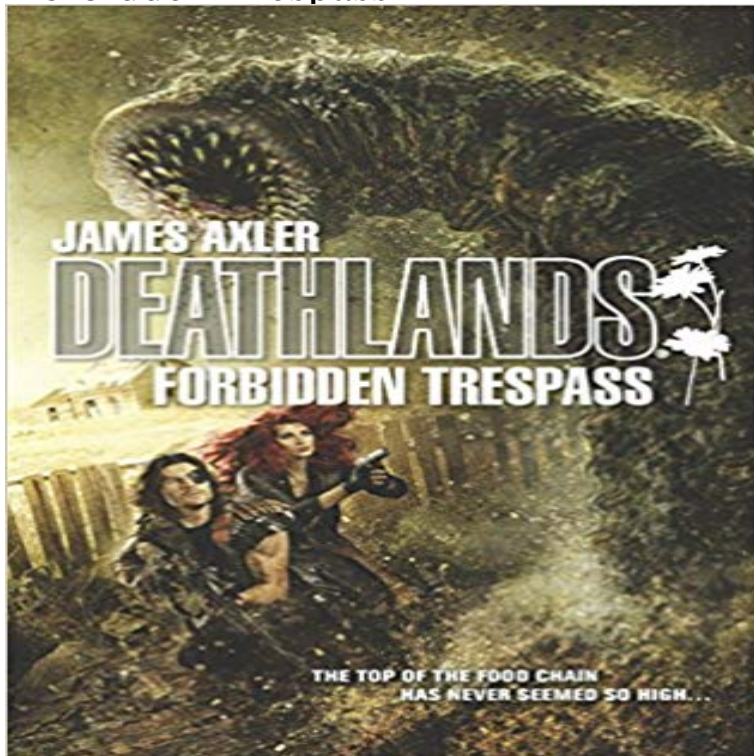


Forbidden Trespass
