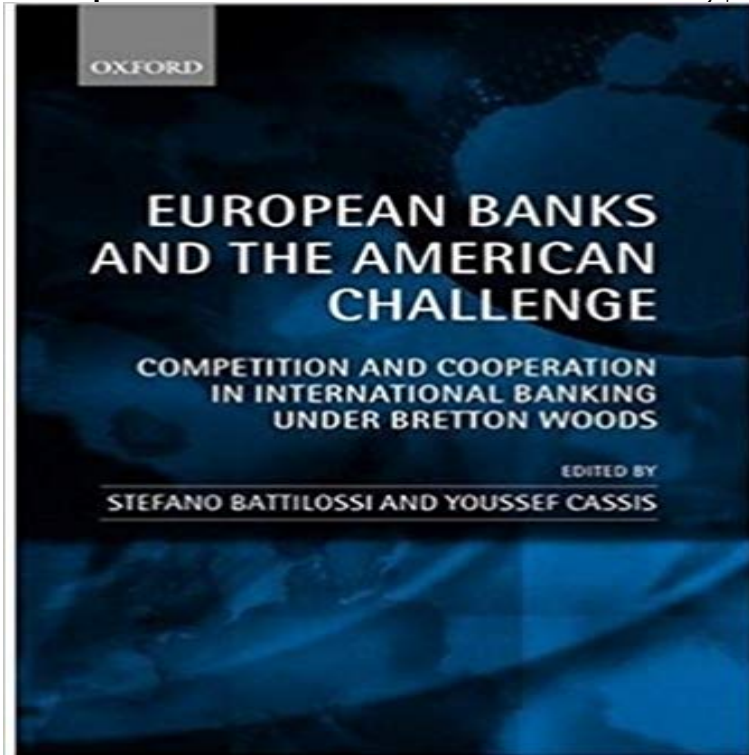


# European Banks and the American Challenge: Competition and Cooperation in International Banking Under Bretton Woods
