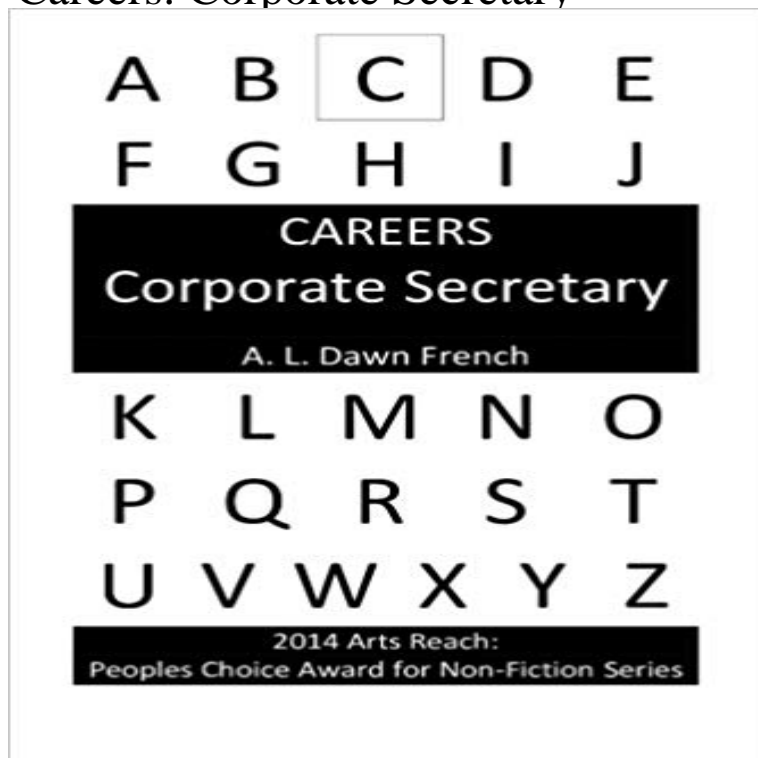


Careers: Corporate Secretary
