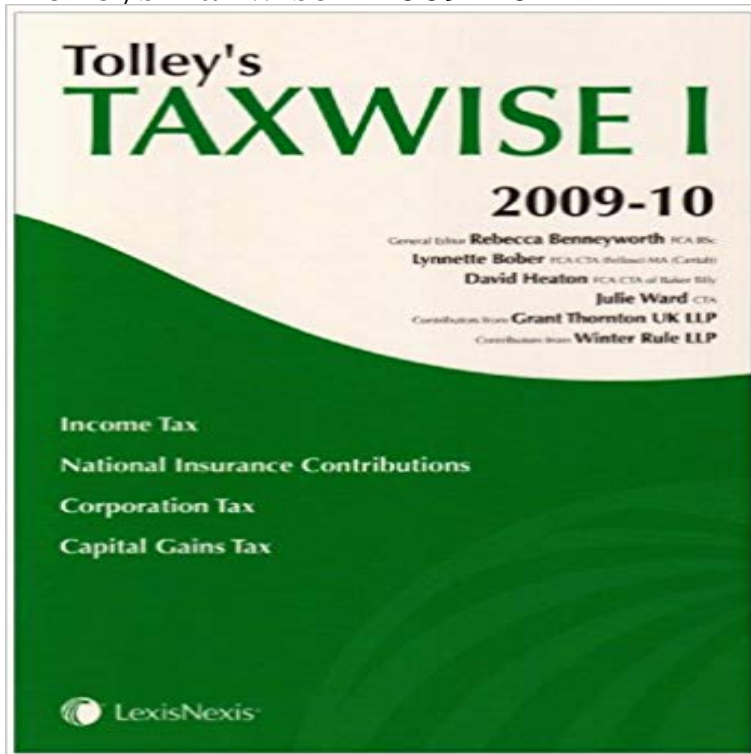


Tolleys Taxwise I 2009-10
